INSTRUMENTATION/ORCHESTRATION LICENSE REQUEST

This license allows you to create instrumental ensemble versions of, or accompaniments for, select music owned by Graphite Publishing (i.e. string quartets, brass ensembles, string orchestra, chamber orchestra, wind band, full orchestra) for your own use.

INSTRUMENTATION VS. ADAPTATION

If merely adding a single instrument part (i.e. creating a solo instrument obbligato part, organ part, etc.), please use the Adaptation License instead.

RIGHTS

Your instrumentation will be considered a “work for hire”, and as such, the publisher retains all rights and control of your work created under terms of this license. This license does NOT grant permission for any sharing or distribution of your instrumentation/orchestration. Any sharing/distribution via print, audio/visual recording, broadcast, etc. requires a separate license request (print, mechanical/sync, broadcast, etc.) Please note, mechanical license income for a derivative work, per standard industry policy, is collected by the original copyright holder, not the arranger, unless an exception is made; and a print license request may or may not be granted (we may choose to publish instead, or not to allow publication.)

FEE

The fee for an Orchestration License (chamber or full orchestral ensemble size) is \$90, which includes permission to create material for your own use only. If you are arranging for a smaller ensemble (e.g., string quartet, brass quintet, etc.) you may request a reduced license fee of \$60.
